Kind fellow citizens,

waste collection in this municipality has been carried out, successfully, by the door-to-door method for decades now.

In order to meet the needs of those who come to spend the weekend here in their homes or of the resident who leaves (for example, for vacation), the Administration has set up an ecological island (id box) in Barozzi Square, which will go into service on Saturday, July 19, 2025.

Access to this service can be activated upon request, by those registered in our TARI role, and is regulated by the new Article 18 of the Municipal Regulations Of Waste Management And Urban Decorum.

Art. 18:

Municipal waste delivery and collection for non-resident users (second homes) at the ecological island (IDBox)

- 1- Resident and non-resident users, <u>registered in the list of TARI users of this Municipality</u>, better specified below, **only if unable to comply** with the schedule referred to in the previous article, may deliver waste **once a calendar week**, properly differentiated and in the appropriate conforming bags (for the delivery of organic waste, it is sufficient that they are placed in biodegradable bags), at the ecological island called IDBox located in the square in front of the headquarters of the Municipality of Bée or at another site identified and communicated later by the Administration while respecting, however, all other rules on delivery.
- 2- Those who decide to take advantage of this service must, upon eventual inspection, demonstrate their actual inability to comply with the schedule.

The following may access the service:

- a- Non-residents homeowners or those with regular rental contracts (excluding those with contracts defined as short) by requesting the activation of their Tax Code.
- b- Residents in case of prolonged absence (e.g., for vacation) by requesting punctually from time to time the activation of their Tax Code;
 - c- When the tax code of the tenant or other entitled person is enabled, the C.F. of the owner is disabled;
- d- In the event of inability to enable the C.F. a replacement card will be issued and its failure to return it will result in a charge to the person in charge of a lump sum of ≤ 100.00 , the owner of the house will be jointly and severally liable by using the right of recourse in full against the author of the failure to deliver. The following are not eligible for the service:

Owners of houses rented (or transferred with other forms e.g. B&B, rooming houses, bailments, etc. etc.) with short term rentals are not eligible for this service and it will be their responsibility/care to instruct their guests of the relevant rules in force so that they put their waste into the normal door-to-door circuit following its rules/calendar** they will be liable in concurrence of persons with the perpetrator of any misconduct of their guests under Art. 5 of Law No. 689 of 24/11/1981;

- 3 Violations of all the rules described and prescribed in this article will result in the application of an administrative penalty under Article 44 of these regulations.
- **- By calendar we mean the separate waste collection calendar that is displayed on the bulletin board every year and can be found on the website of the municipality of Bèe in (news notices) \rightarrow (environment, green waste) \rightarrow (separate waste collection calendar year 2025) \rightarrow (download attachment).
